SUPPLY AGREEMENT

Amounts due as a result of any and all rentals/purchases hereafter made by Customer from Supplier will be paid to Supplier on the following terms and conditions.

TERMS:

Unpaid invoices are past due 30 days from date of invoice. If at any time Customer fails to pay invoices when due, or if for any reason Supplier feels insecure in extending credit, Supplier may decline to provide further goods on credit.

LATE PAYMENTS:

Past due accounts are subject to a late charge of one and one-half percent (1-1/2%) on the amount overdue.

BAD CHECKS:

A service charge of \$30.00 or the maximum allowed by law will be applied to each returned check.

FAILURE TO PAY OR INSOLVENCY:

Failure by Customer to pay any part of the account when due, or in the event that proceedings in bankruptcy, receivership or insolvency are instituted by or against Customer or his property, Supplier may at his option, cause the entire unpaid balance to become due immediately payable and Supplier shall have the right to enter at anytime without notice upon the premises where any of the materials procured by the Customer from Supplier are located. Customer hereby expressly waives any right to action which may accrue by reason of the entry for taking possession of or the selling of with respect thereto including service charges and reasonable attorney's fees and court costs. Customer will be liable for all costs of collection, including but not limited to attorney's fees, if necessary.

ENTIRE AGREEMENT:

This Agreement covers all materials that the Customer may hereafter acquire at any time from Supplier. This Agreement constitutes the entire agreement with Supplier. No waivers or modifications shall be valid unless the same are in writing and executed by the parties hereto. This Agreement shall apply and accrue to the benefit of, and be binding upon, the heirs, executors, administrators, successors and assigns of the respective parties.
